Below is an overview of the Rattlesnake Rimfire Challenge, if you have any questions please direct them to me.

Welcome to the **5th Annual Rattlesnake Rimfire Challenge**. This is a season long points series based on four separate Rimfire Matches conducted by the High-Power discipline.

- Mini-PALMA Match (week-end matches)
- 100/200 Smallbore Prone Match
- 100 Rimfire Match
- CMP Rimfire Match

Shoot in as many Matches as you wish, your best scores from each Match are summed and the highest cumulative score gets their name on the "John Hill Cup" and bragging rights for the following year!

There is NO cost to participate, if you shoot in one of the Matches, you're entered!!

Two of many Matches are in the books. Charles Bonham is walking his talk as he was in second place last year and even closer the previous year, promised a different outcome this year. He has a TWO-point lead over Phil Keuhlen. The defending champion, George Hager, is in third place.

We hope to see you out there with us ... Get to the Hill!

TCSA FACILITIES

ROSE-IRIS RANGE – A 100-yard range with 20 covered firing points. This day use Range Safety Officer supervised facility is operated for public use on a regularly scheduled basis Wednesdays, Fridays, Saturdays and Sundays.

RIMFIRE PLINKING RANGE – A 50-yard 22-caliber Range Safety Officer supervised Shooting Range with reactive targets.

CENTERFIRE PLINKING RANGE – A 50-yard handgun pistol/revolver RSO supervised range with reactive targets for firearms using black powder or standard pistol cartridges.

COWBOY / PRACTICAL PISTOL BAYS – Ranges consisting of 13 bays of varying lengths designed to support a variety of action shooting disciplines such as; Practical (IPSC/ USPSA) 3-Gun Sports and Cowboy (SASS) groups.

1000-YARD, HIGH-POWER RANGE – A Range consisting of 100, 200, 300, 600, 800, 900 & 1000-yard firing lines that can support 20 firing stations on each firing line (utilizes manned target operation). The 400-yard line has 5 firing stations and the 500-yard line has 10 firing stations. This Range supports High-Power Rifle, Long Range PALMA and Precision Shooting Events of various disciplines, including 50-Caliber.

HUNTER EDUCATION RANGE: This Range has been designed to support Hunter Education Training Classes and also has a practical field exercise area containing obstacles hunters could expect to encounter in the field. The covered firing line can be used independently by current RSO's as an overflow from the Rose-Iris Range and may be available for RSO supervised public event use when not being used for the conduct of Hunter Education Classes.

Nothing has changed since last month. We are still unable to hold in-person Hunter Education Classes. We are hopeful that will change sometime this summer, but it remains to be seen.



Students who are age 9 or older can still complete the entire course through the Online Process. Younger students will have to complete the field exercise in person when classes are again offered.

RSOs using the HESA Range are expected to sign in at the Rose-Iris Range before going over to the HESA Range to shoot. You are also expected to clean up after you are done shooting, including returning target stands to the Rose-Iris Range House and picking up all brass.

Always remember to control the direction of your muzzle, be sure of your target and what lies beyond it, keep your finger off the trigger until you are ready to shoot and always check every cartridge to make sure it is the correct ammunition for your firearm.

Keep the Range Clean

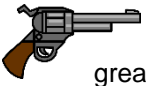

SHOTGUN REPORT

We will be into April by the time you read this and as I write this the Tri-Cities is under a high wind advisory with wind gusts of 60 mph possible. Not to be out done, the weather station at the Shotgun Range registered a high gust of 70 mph at 2:04 p.m. We all know the wind blows at Rattlesnake, so what does this have to do with anything? Nothing really, but the garbage can from the 5-Stand field is probably a ¼ mile out into the field by now.

If there was ever a shoot that was close to perfect, you could say the **2021 Sub-Gauge Shoot** was it. The weather was sunny and warm all day, the winds remained calm and there were no real issues all day. The 5-Stand target presentations were setup well for a Sub-Gauge Shoot, which as I have written about before can sometimes backfire when you try to make the course “easy”. There was a good turn-out with shooters coming from Walla Walla, Pendleton and Western Washington as well.

Rattlesnake was represented well with our Members taking 4 out of the top 5 spots. Of course, with individual gauge winners as well as an overall lewis class there were quite a few winners of the day. A familiar name won the overall, but it was pretty darn close this year. A couple of targets either way could have seen the lead go to a couple of different shooters.

RU & 28ga Class Winner: Mark Monopoli 94/100
16ga Winner: Mike Inglima 64/100
20ga Winner: Ted Pitt 92/100
Dave Otto Hardluck Award: Bernie Foster 53/100

Now, the shoot went swimmingly, but that doesn't mean some individual shooters didn't have issues. If Wilgus is in charge everything is straight and to the point, there is no ambiguity regarding any rules. To start off, John makes it very, very clear that there are no malfunctions, slow pulls, misfires, etc. In John's exact words, “If you call pull and a bird comes out and you don't shoot it, it's a loss.” Period, end of discussion, that's the way it is folks.

As we all know the universe has a pretty good sense of humor sometimes, and on this day, it was no different. First casualty of the rule? **Larry Brown** was shooting in my squad and on the very first bird of trap, Larry forgot to take his safety off. Lost bird. Next victim? **Jeff Spivey** and his wife **Bernie** drove over from north of Seattle. Jeff was shooting his singles on Skeet station 2 when he loaded only one shell to shoot a single bird. In Jeff's own words “I told myself to load (2) shells, but then I thought why do I need to load two shells for 1 bird?” Well, when your only shell is a light strike on the primer, that second shell would have come in handy. Now we come to the final victim of the rule that I'm aware of. **Mr.**

John Wilgus is on Skeet 1, shooting the high house when he encounters a shell with a dished primer. Nothing goes bang, the bird goes to ground, loss. You can call it poetic justice, karma or just a mere coincidence, but I will tell you I personally found it highly amusing. Unfortunately, in the end John laughed last, and still took home the win.

One of the cool things from the shoot is that we used the awesome new forklift with the mast extended to full height to throw a tower bird for the 5-Stand. It worked perfectly and added some more depth to our target presentations.

2021 Skeet League will begin **May 1** at 9:00 a.m.! Be there or be square! League will be held every Saturday during the fine month of May and there is no limit to the number of rounds you can score on a single day! Want to score all (10) rounds in one day, go for it! Skeet League is a good time where you get to sit around and watch shooters disappoint themselves round after round after round. Come join the fun and disappointment!

5-Stand is **OPEN for business** on **Sundays** at 9:00 a.m.! The ever-popular shooting game is back and we are picking up where we left off in 2020. One thing to note, if you are going to shoot be sure to get there at 9:00 a.m. or close to it. 5-Stand is only open while we have shooters, once everyone is done it gets shut down for the day.

Safety is priority one whether you are shooting trap, skeet or 5-stand. Please remember, if you see an orange cone out on any of the fields it means the field is closed until the cone is removed. If you see something, say something.
