

**OVERNIGHT CAMPING AGREEMENT FOR TCSA RANGES 9/16/2020**

- 1. Overnight camping on the Rattlesnake Mountain Shooting Facility (RMSF) will only be allowed for those individuals participating in scheduled shooting matches or other discipline events. There must be a discipline TCSA certified RSO present to oversee and ensure safety compliance. No other public overnight camping is allowed on the RMSF.**
- 2. Each camper must sign an Overnight Camping Agreement indicating their concurrence with these Rules, and any other rules required by their respective shooting discipline, to be kept by the discipline sponsoring the event and submitted to the TCSA after the event's completion.**
- 3. Campers will be given a gate proxy card to allow them to enter and exit their respective camping area. Gates must remain locked prior to 9:00 AM and after 3:00 PM to prevent unauthorized access to the RMSF. Proxy cards will be returned to the match/event coordinator at the conclusion of the camping event.**
- 4. Campers may use the local installed Port-a-Potties, BUT the HESA/Rose-Iris Ranges and the Shotgun Range kitchen, toilet facilities, & grounds are off limits for overnight camping or for use by campers. All vehicles and campers must always remain on graveled roads or designated parking areas.**
- 5. Alcoholic beverages are NOT allowed on the RMSF property.**
- 6. Pets & children must be supervised, and their parents/owners are responsible for properly disposing of any waste or cleaning up any mess they create.**
- 7. Quiet Time will be observed from 10 PM to 6 AM (generators turned off).**
- 8. All garbage and debris must be removed from RMSF property and shall be deposited in an appropriate on or off-site garbage container. The discharge/leakage of any amount of oil, grease, gasoline or diesel fuel, other petroleum products, antifreeze, acid, camper grey or black water, on RMSF property is prohibited.**
- 9. No Open fires unless preauthorization is received from the TCSA and the Benton County Fire Dept. Fireworks are not permitted to be used on the RMSF properties.**
- 10. Shooting activities are only allowed at any of the RMSF Ranges when a currently certified TCSA Range Safety Officer (RSO/RO) is present**
